Faith Aligned Humanitarian Network: Partnership and Affiliation Overview

I. Purpose of This Brief

This brief is prepared for pastors, ministry leaders, church administrators, and nonprofit directors who are exploring a partnership or affiliation relationship with The SAVI Ministries through the Faith Aligned Humanitarian Network.

It describes what the network is, how it functions, what partnership means in practice, and how interested organizations may begin a formal engagement conversation with the ministry.

II. What the Faith Aligned Humanitarian Network Is

The Faith Aligned Humanitarian Network is one of the three integrated execution engines of The SAVI Ministries. It is a distributed partnership infrastructure composed of churches, ministries, nonprofits, and allied humanitarian entities that share a commitment to advancing Christian mission and compassionate service to vulnerable communities.

The network is not a denominational affiliation system. It is not a membership organization. It is not a church directory. It is a structured field access and mission coordination infrastructure — the organized ground-level presence of the ministry's humanitarian platform across the Americas and related mission environments.

Participating entities operate with full independence in their own governance, spiritual leadership, and ministry activities. The SAVI Ministries does not seek to influence the doctrinal direction, pastoral leadership, or internal governance of network partners. The relationship is one of shared mission and cooperative service rather than hierarchical authority.

III. The Role of Network Partners

Network partners serve as the local and regional presence of the ministry's humanitarian mission. They provide:

- **Field access:** Local relationships, community trust, and geographic reach that allow humanitarian assistance to be delivered effectively to individuals and communities in need.
- **Mission context:** On-the-ground understanding of community needs, cultural realities, and practical service requirements that inform the ministry's humanitarian response.



- **Cooperative service:** The ability to carry out certain humanitarian initiatives, outreach programs, and community activities with the support, coordination, or funding of The SAVI Ministries where missions align.
- **Spiritual presence:** The expression of the ministry's spiritual calling through local pastoral relationships, community service, and the proclamation of the Gospel in the communities they serve.

IV. Partnership Framework Documents

The SAVI Ministries provides two formal framework documents governing network participation:

Church Mission Partnership Charter

The Church Mission Partnership Charter establishes the cooperative framework through which ministries may work alongside The SAVI Ministries in humanitarian initiatives, outreach efforts, and other works of service. It is designed to provide a clear and respectful foundation for cooperation while preserving the full independence of each participating ministry. This document is available upon request through the institutional engagement pathway.

Mission Support and Affiliated Ministry Recognition Statement

The Mission Support and Affiliated Ministry Recognition Statement allows The SAVI Ministries to formally acknowledge ministries whose work reflects alignment with the spiritual values and humanitarian mission of the institution. This recognition affirms the relationship of fellowship and shared mission without creating a formal hierarchical relationship or financial obligation between the parties.

V. Criteria for Network Participation

The SAVI Ministries welcomes partnership inquiries from organizations that meet the following general criteria:

- Operates as a church, Christian ministry, or faith-aligned nonprofit organization
- Is engaged in activities consistent with Christian principles and the advancement of compassionate service to others
- Maintains an identifiable institutional structure and recognized pastoral or organizational leadership
- Shares a commitment to human dignity, humanitarian care, and responsible stewardship of resources
- Operates with integrity consistent with the mission standards of The SAVI Ministries

The ministry does not require doctrinal uniformity beyond a shared foundation in Christian faith and mission. Partners represent a diversity of cultural contexts, traditions, and ministry expressions. What is required is mission alignment and ethical integrity — not cultural or denominational conformity.



VI. How to Begin a Partnership Conversation

Organizations interested in exploring a network partnership relationship with The SAVI Ministries are invited to initiate contact through the institutional engagement pathway on the ministry's website at www.thesaviministries.org/partner

Initial inquiries are reviewed by the Office of the Chairman. Organizations that appear to represent a meaningful alignment of mission and values will be invited into a formal engagement conversation, which may lead to the execution of a Church Mission Partnership Charter or Mission Support and Affiliated Ministry Recognition Statement, depending on the nature of the relationship.

The partnership conversation is not a one-way review. It is a mutual discernment process, the ministry seeks relationships that are genuinely collaborative, mutually beneficial, and grounded in shared commitment to advancing compassionate service.

VII. What Partnership Does Not Require

To be clear about what the network partnership relationship does not entail:

- Network partners are not required to transfer governance authority or financial control to The SAVI Ministries
- Network partners are not required to adopt the doctrinal positions of any other partner or of The SAVI Ministries beyond general Christian faith alignment
- Network partnership does not create a fundraising obligation or financial commitment for the participating organization
- Network partnership does not replace or displace existing ministry relationships, denominational affiliations, or cooperative agreements
